

ORDINANCE NO. 52
ORDINANCE OF THE HYDESVILLE COUNTY WATER DISTRICT,
AMENDING ORDINANCE NO. 4 TO PROVIDE FOR AN AUTOMATIC INCREASE IN
WATER RATES AND METER CHARGES

Be it ordained by the Board of Directors of the Hydesville County Water District, Humboldt County, as follows:

1. Paragraph 270 of Ordinance No. 4 of the Hydesville County Water District, which establishes rates, rules and regulations for water service for said District, is hereby amended to read as follows:

270 Rate Schedule – Rates for water service are established as follows:

BI MONTHLY RATE SCHEDULE Meters serving one dwelling unit on a parcel:

Minimum Water Service Charge - Includes 1100 cubic feet \$117.00 (every 2 months)
Quantity Charge - Usage over 1100 cubic feet..... \$ 6.50 per 100 cu. ft.

Meters serving more than one dwelling unit on a parcel

(Meters serving more than one dwelling unit on a parcel, including, but not limited to, multiple units, mobile homes or trailers in trailer parks, or elsewhere, and separate dwelling units on a single parcel)

Minimum Water Service Charge – multiplied by the number of dwelling units

Includes allotted cubic feet multiplied by the number of dwelling units.....\$117.00 per dwelling unit (2 months)

Quantity Charge - Usage over 1100 cubic feet multiplied by the number of dwelling units \$ 6.50 per 100 cu. ft.

- 1 cubic foot is equal to 7.48 gallons.
- 1 unit is 100 CF or 1 HCF
- 1100 CF is 8,228 gallons.

Increases will be phased in over a four-year period. Rates will be in effect beginning October 1st, 2026, and will be increased each October 1st thereafter, with the final increase on October 1st, 2029.
